

**BACKGROUND**

1. Tarrant County ("COUNTY") and the City of Fort Worth ("CITY") entered into an Agreement approved by Tarrant County Commissioners Court Order No. 104655, for the cooperative funding of improvements to Golden Triangle Boulevard ("Project") as described in the 2006 Tarrant County Bond Program.
2. The Project is not complete and the COUNTY and the CITY desire to renew the Agreement for the 2012 Fiscal Year.

Therefore, the COUNTY and CITY agree to the following

1. The COUNTY and the CITY renew the Agreement for the COUNTY's 2012 Fiscal Year with the Agreement to expire September 30, 2012 or the completion of the Project as determined by the COUNTY, whichever occurs sooner.
2. The COUNTY and CITY agree to the revised payment schedules.
3. All terms and conditions of the original Agreement as amended remain in effect except to the extent modified by this Renewal.
