



NOTES

1. AT LEAST 48 HOURS PRIOR TO COMMENCEMENT OF WORK, CONTRACTOR SHALL NOTIFY BUSINESS OWNERS OF PLANNED CLOSURES AND DETOUR ROUTE.
2. ALL TEMPORARY TRAFFIC CONTROL DEVICES SHALL CONFORM TO SECTION 6 OF THE TEXAS MUTCD.
3. CONTRACTOR SHALL PROTECT THE WORK ZONE FROM ALL VEHICLES AND PEDESTRIANS WITHIN THE PARKING LOT.
4. CONTRACTOR SHALL MAINTAIN ACCESS TO ALL BUSINESSES.
5. VERTICAL PANELS SHALL BE SPACED AT 35 FEET CENTER TO CENTER IN TAPER AND SHIFT ZONES AND 70 FEET CENTER TO CENTER IN TANGENT ZONES.
