

By this letter, the Southwestern Exposition and Livestock Show does hereby request a waiver of City Code, Section 24-8, Entering Closed Areas, Hours of Operation and Section 24-10, Riding, Tethering or Pasturing to be in Trinity Park from 11:30 p.m. – 5:00 a.m. beginning Monday January 12 through Sunday, February 8, 2015 for the sole purpose of allowing livestock competitors to prepare for activities associated with the competition during the Stock Show. These exceptions will run within the Trinity Park Drive closure time period requested by letter of event date sent to the City of Fort Worth, a copy of which is attached hereto.

This waiver is being requested in the interest in public safety, specifically traffic management on University Drive from Trail Drive to I-30.
