**ARTICLES OF INCORPORATION
OF
THE MAREDI CORPORATION**

The undersigned, a natural person of the age of eighteen (18) years or more, who is a citizen of the State of Texas, acting as incorporator of a corporation under the Texas Business Corporation Act, hereby adopts the following Articles of Incorporation (the "Articles") for such corporation:

**ARTICLE ONE
NAME**

The name of the corporation is "The Maredi Corporation."

**ARTICLE TWO
DURATION**

The period of its duration is perpetual.

**ARTICLE THREE
PURPOSE**

The purpose or purposes for which the corporation is organized to engage in and transact any or all lawful business for which corporations may be organized under the Texas Business Corporation Act.

**ARTICLE FOUR
CAPITALIZATION**

The aggregate number of shares that the corporation has the authority to issue is one hundred thousand (100,000) shares of the par value of one cent (\$.01) each. The shares are designated Common Stock (herein so called) and have identical rights and privileges in every respect.

**ARTICLE FIVE
COMMENCEMENT OF BUSINESS**

The corporation will not commence business until it has received for the issuance of its shares consideration of One Thousand and No/100 Dollars (\$1,000.00) in money, labor done, or property actually received.

ARTICLE SIX
NONCUMULATIVE VOTING

Directors shall be elected by majority vote. Cumulative voting shall not be permitted.

ARTICLE SEVEN
PREEMPTIVE RIGHTS

The preemptive rights of a shareholder to acquire unissued or treasury shares of the corporation are neither limited nor denied.

ARTICLE EIGHT
REGISTERED OFFICE AND AGENT

The post office address of the initial registered office of the corporation is 835 E. Lamar Boulevard, Suite 246, Arlington, Texas 76011, and the name of its registered agent at such address is Nouman Ibrahim.

ARTICLE NINE
DIRECTORS

The number of directors constituting the initial Board of Directors is two and the name and address of the person who is to serve as director until the first annual meeting of the shareholders, or until his successor is elected and qualified, is:

SHAREHOLDER CONSENTS

Any action required to be taken at any annual or special meeting of shareholders, or any action which may be taken at any annual or special meeting of shareholders, may be taken

without a meeting, without prior notice, and without a vote, if a consent or consents in writing, setting forth the action so taken, shall be signed by the holder or holders of shares having not less than the minimum number of votes that would be necessary to take such action at a meeting at which the holders of all shares entitled to vote on the action were present and voted.

**ARTICLE ELEVEN
INDEMNIFICATION**

Farley Custom Homes, Inc. shall indemnify all officers and directors and incorporators who were, are or are threatened to be made a defendant or respondent in a proceeding because the person is or was an officer or director of the corporation if it is determined that the person conducted himself in good faith and reasonably believed that his or her conduct, in his capacity as an officer or director, was in the best interest of Farley Custom Homes, Inc. and in all other cases, that his conduct was at least not opposed to the best interests of Farley Custom Homes, Inc.

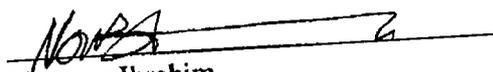

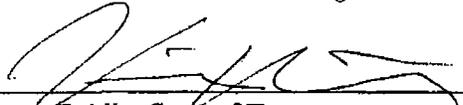

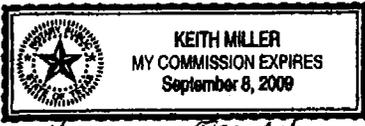
