North 30 degrees 08 minutes 40 seconds West continuing along the west R.O.W. line of said Alley and the east line of said TRWD tract, a distance of 150.00 feet to a 1/2 inch capped iron rod found stamped "Brittain & Crawford"), being the northeast corner of said TRWD tract and the southeast corner of a tract of land described in a deed to Tarrant Regional Water District, recorded in Instrument No. D215191437, D.R.T.C.T.;

North 30 degrees 10 minutes 05 seconds West continuing along the west R.O.W. line of said Alley and the east line of said TRWD tract, a distance of 100.00 feet to an X in concrete found (control monument), being the northeast corner of said TRWD tract and the northwest corner of said 10 foot Alley, on the south R.O.W. line of N.W. 8th Street (a 50' R.O.W.);

North 59 degrees 49 minutes 55 seconds East along the south R.O.W. line of said N.W. 8th Street, the north line of said Alley, a distance of 10.00 feet to an X in concrete found, being the northeast corner of said Alley and the northwest corner of a tract of land described in a deed to Tarrant Regional Water District, recorded in Instrument No. D215191437, D.R.T.C.T.;

**THENCE** 

South 30 degrees 10 minutes 05 seconds East along the east R.O.W. line of said 10 foot Alley and the west line of said TRWD tract, a distance of 250.00 feet to the southwest corner of said TRWD tract and the northwest corner of a tract of land described in a deed to Tarrant Regional Water District, recorded in Instrument No. D216216337, D.R.T.C.T.;

**THENCE** 

South 30 degrees 07 minutes 01 seconds East continuing along the east R.O.W. line of said Alley, the west line of said TRWD tract, a distance of 150.18 feet to the **POINT OF BEGINNING** and containing 4,013 Square Feet or 0.092 Acre of Land.
