COMMENCING at a found 1/2—inch iron rod for the most northerly northwest corner of said "Tract 1" on the south right—of—way line of Sycamore School Road (a variable width right—of—way) as recorded in Cabinet A, Slides 9815—9817, Plat Records of Tarrant County, Texas, said corner being the beginning of a circular curve to the left having a radius of 1,265.00 feet and whose chard bears North 68 degrees 38 minutes 18 seconds East a distance of 265.32 feet;

THENCE Northeasterly, along the south right—of—way line of said Sycamore School Road and along said curve to the left, through a central angle of 12 degrees 02 minutes 21 seconds and an arc distance of 265.81 feet to a point for corner;

THENCE North 62 degrees 37 minutes 24 seconds East, continuing along the south right—of—way line of said Sycamore School Road, a distance of 748.27 feet to the POINT OF BEGINNING;







BEGINNING at a found 1/2—inch iron rod for the most easterly southeast corner of sold "Tract 1" on the west right—of—way line of Summer Creek Drive (a variable width right—of—way);

THENCE North 83 degrees 05 minutes 27 seconds West, departing the west right—of—way line of said Summer Creek Drive and crossing said "Tract 1", a distance of 908.55 feet to a point for corner;

THENCE North 00 degrees 28 minutes 04 seconds West, continuing across sold "Tract 1", a distance of 203.75 feet to a point for corner;

THENCE North 89 degrees 33 minutes 46 seconds East, continuing across sold "Tract 1", a distance of 34.38 feet to a point for corner, said corner being the beginning of a circular curve to the left having a radius of 145.00 feet and whose chord bears South 41 degrees 45 minutes 50 seconds East a distance of 191.50 feet;





THENCE Southeasterly, departing the south right-of-way line of said Sycomore School Road and along said curvs to the left, through a central angle of 00 degrees 07 minutes 12 seconds and an arc distance of 27.57 feet to a found 1/2—inch iron rod for the POINT OF BEGINNING;

THENCE North 89 degrees 52 minutes 12 seconds East, crossing said "Tract 1", a distance of 765.15 feet to a point for corner said corner being the beginning of a circular curve to the left having a radius of 145.00 feet and whose chard bears North 49 degrees 28 minutes 14 seconds East a distance of 190.55 feet;
